The Georgia State Golden Gloves is designed to provide all amateur boxers with a platform where they can show their talents.

Sugar Bert Boxing Promotions is hosting the Georgia State Golden Gloves scheduled for Friday, June 11 – Sunday, June 13, 2021. We invite you, your boxer(s), and your club to compete in the 2021 Georgia State Golden Gloves. This event is sanctioned by **USA Boxing**.

This is a 3-day boxing event for **ALL** boxers of **ALL** weight divisions. The elite champions for each division will advance to Birmingham, AL to the Southern Golden Gloves Regional Tournament of Champions to be held July 15-17, 2021. The National Golden Gloves Tournament will be held in Tulsa, OK August 7-15, 2021.

Online registration for the Georgia State Golden Gloves is located on the www.sugarbertboxing.com website. Online registration fee is \$25.00 per boxer. **Registration is Online only. No Walk-ups.**

Boxers who registered online in 2020, that paid, must register online to be eligible at the 2021 Georgia Golden Gloves.

Limited pre-matched bouts will be allowed.

Those who compete and win will receive a Title Belt from Title Boxing. All unopposed or runner –up boxers at this Event will receive either a Medal, T-shirt, or Title hand-wraps. **International boxers are welcomed to compete at this event.**

All participants (Coaches, Boxers, and Officials) must check in on Friday, June 11, 2021. Registration and general weigh-ins will be held on **Friday, June 11, 2021**, from 12 Noon – 8 pm, EST.

Coaches who do not register online or are not present during registration on Friday, June 11, 2021; will be required to pay admission fees on Saturday, June 12th and Sunday, June 13th, 2021.

There will be an area set up for Sugar Bert Boxing Tournament Staff to check in and verify all participants. All participants must provide a current USA Boxing passbook, with a 2021 membership card attached to their passbooks. Coaches and Officials must show proof of current certification. All boxers must have a current physical attached to compete.

If an **annual physical** is needed, please check medical clinics within the area.

Check-in is mandatory for all boxers, in order to be placed on the brackets.

Trial Scales:

Trail scale(s) will be available during registration on and prior to daily weigh-ins at 8:00 am EDST and throughout competition. Location and times during competition will be posted.

Daily weigh in:

Weigh in will be held at Eastside Boxing Club.

Daily weigh-in for boxers will begin at 8:30 am, EDST

Matched Bouts:

Pre-Unopposed athletes may be eligible for matched bouts. If you are interested in a match bout, please attend the coaches meeting for more instructions. A list of unopposed athletes will be provided by Tony Williams and / or Tournament Director and displayed on Facebook.

Matched bouts will be verified based on the LBC Competition Guidelines and then placed on the bout sheet for Saturday or Sunday competition.

Weigh-in Rosters:

Weigh-in rosters will be posted after the coaches meeting.

Every boxer and/or coach must confirm they have been placed into the correct age bracket and weight class before the brackets are published; no changes will be made on June 12, 2021.

Brackets:

Tournament brackets and bout sheets will be posted on the Sugar Bert Boxing Promotions Facebook page, and at the event center following registration.

Based on the number of boxers in your weight class and division there may be bouts scheduled for Friday, June 11th, 2021.

Any discrepancies should be reported to Tournament Supervisor, Kenneth Tate at 916-236-7407, immediately.

Scorecards:

The Tournament Director (or assigned COO) will allow coaches to view the judges' scores from their boxer's bout. To receive a copy of your bout scorecards, coaches should first exit the Field of Play after the conclusion of the bout and wait for one bout to pass before submitting the request to the Tournament Director. The scorecards will be printed onto a Supervisor's Report and available 30 minutes after the request has been made. Coaches may request to discuss the scores privately with the Tournament Director.

Passbooks:

Please allow 30 minutes after the conclusion of the bout to pick up the boxer's passbook. Please do not stay in the field of play.

Coaches:

All coaches must present a red coaches' passbook, with current 2021 membership card, current coach and Safe Sport certification.

Officials:

All officials must present a blue officials' passbook, with current 2021 membership card, current official and Safe Sport certification.

All participating members should be aware that we represent USA Boxing and that we are ambassadors for the sport of amateur boxing. The conduct of all participants both inside and outside the Field of Play should demonstrate exemplary behavior, always. Any participant deemed guilty of misconduct will be subject to disciplinary actions as listed on the USA Boxing Code of Conduct. All participants must adhere to the **USA Boxing Code of Conduct**, which must be signed at registration.

The Georgia State Golden Gloves will be using the new AIBA age group definitions as well as the AIBA rule. Your boxer's age will be determined by the boxer's year of birth.

All male elite boxers with zero (0) to ten (10) bouts will be a Novice Division, at five (5) bouts a boxer may elect to enter the Open Division. A boxer on his/her eleventh (11th) Bout must be competed as an Open Boxer. Once the boxer declares to be in the Open Division, he/she cannot return to the Novice Division.

Elite Division (19-40 years old):

An elite boxer must be at least 18 years of age on or before June 12, 2021. Boxers who are 18 years old can elect to elevate to the Elite Division, as long as they are already 18 years old on or before the tournament date. Elite boxers must be born between the years of 1981 – 2002.

Youth Age Division:

Youth boxers must be 17 or 18 years of age, determined by the year of birth. This means the boxer must be born between the years of 2003 or 2004.

Number of Rounds/Duration:

Three – 3-minute rounds

Junior Age Division:

Junior boxers must be 15 or 16 years of age, determined by the year of birth. This means the boxer must be born between the years of 2005 or 2006.

Number of Rounds/Duration:

Three – 2-minute rounds

Intermediate Age Division:

Intermediate boxers must be 13 or 14 years of age, determined by the year of birth. This means the boxer must be born between the years of 2006 or 2007.

Number of Rounds/Duration:

Three – 1.5-minute rounds

Bantam Age Division:

Bantam boxers must be 11 or 12 years of age, determined by the year of birth. This means the boxer must be born between the years of 2007 or 2008.

Number of Rounds/Duration:

Three – 1-minute rounds

Pee Wee Age Division:

Pee Wee boxers must be 8, 9 or 10 years of age, determined by the year of birth. This means the boxer must be born between the years of 2010, 2011 or 2012.

Note: Pee Wee 8 years of age will only compete against another 8-year-old. Boxers in the Pee Wee 8-year-old division at the start of the qualifier will compete as an 8-year-old. Those already 9 years old or born in 2011 will compete in the Pee Wee 9-10 division.

Number of Rounds/Duration: Three – 1-minute rounds

The following weight classes will follow the USA Boxing Rule Book, as shown in the “Rules at a Glance” (appendix F).

Headgear: Headgear will be worn throughout the event by all boxers. All boxers must wear USA Boxing approved headgear.

Gloves: Sugar Bert Boxing will provide competition gloves for all age and weight divisions throughout this event.

Uniform: All boxers’ uniform must have a color contrasting waistband. NO adornment may be affixed to the trunks such as metal or plastic, objects, sequins, etc. No flapping material, gladiator or Thai type trunks, fringes or tassels
